Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school from class I to XII shall be restricted to 57 of which not more than 18 sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. The school is directed to run at least 01 section each of bal-vatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
2	School website https://princesainikschool.com/ is functional but selective documents are published and video & appendix-IX are not uploaded on the website. As per Board guidelines and circular no 09/2021 the school should have a functional website with all mandatory documents available on the 'Mandatory Public Disclosure' link for easy access to the public on school website in compliance of Circular No : 09/2021 Date of (21 May 2021). School shall provide all mandatory disclosures with link in prescribed formats within 03 months and submit compliance.
3	As per the inspection committee the School is fully residential and the facility of residence and hostel is running in 5 blocks of the school whereas 2 blocks are being used as academic purpose. But the School has mentioned 'NO' against the residential column in the OASIS data. School shall update the details in OASIS w.r.t. residential school and submit an undertaking that school is adhering the guidelines as mentioned in the Clause 14.27 of the Affiliation Bye Laws of the Board immediately and upload the same under compliance on SARAS portal within 03 months.

4	Regular Cubicles converted into CWSN toilets with installation of handrail. Entrance of the toilet and passage is very narrow. Toilet is very narrow and navigation of the wheelchair or walker is not possible inside the toilet. The entrance/gate is also narrow. Thus, the school is required to construct accessible and spacious CwSN toilet on each floor separately for Boys and Girls with handrails on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per the guidelines issued by the Board and the provisions laid down in the RPwD Act 2016.
5	Separate reading area for the staff is not developed by the school in the Library. ICT infrastructure is not available in the library as mentioned in SoP. Space for project and activity is not available in the library. School shall upgrade the library in the light of SoPs within 03 months and submit compliance.
6	Facilities such as LMS, Webcam, interactive Board, projector and speakers are also not available in the lab. School shall procure more computers for the lab and upgrade the lab in the light of SoP issued by the Board within 03 months and submit compliance.
7	The school shall ensure the mandatory training of its teachers with CoE, CBSE, Ajmer within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws- 2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
